**EXTENSION OF PROHIBITION ON EXPORTS TO COTE D'IVOIRE UNDER
UNSC RESOLUTION 1727 (2006)**

Further to our Customs Circular No. 25/2005 dated 16 Dec 2005 and Circular No. 27/2004 dated 11 Dec 2004, we wish to inform you that the exports from Singapore to Cote d'Ivoire of the following items remain prohibited under Regulation 6(1)(b) of the Regulation of Imports and Exports Regulation (Rg 1) until further notice:

- (1) Arms and related materials of all types, including -
 - (a) weapons;
 - (b) ammunition;
 - (c) military vehicles;
 - (d) military equipment; and
 - (e) paramilitary equipment.
- (2) Military aircraft of all types.
- (3) Spare parts of any item falling under paragraph (1) or (2).

Penalties

2 Any person who contravenes the prohibition shall be guilty of an offence and shall be liable on conviction –

- a) to a fine not exceeding \$100,000 or 3 times the value of the goods whichever is greater, or to imprisonment for a term not exceeding 2 years or to both; and
- b) on the second or subsequent conviction to a fine not exceeding \$200,000 or 4 times the value of goods, whichever is greater, or to imprisonment for a term not exceeding 3 years or both.
