LISTING OF BRAZILIAN ROSEWOOD (*Aniba rosaeodora*) AND VERAWOOD (*Bulnesia sarmientoi*) ON CITES APPENDIX II

Singapore is a Party to the Convention on International Trade in Endangered Species of Wild Fauna and Flora (CITES), which is an international agreement to ensure that trade does not threaten species with extinction.

At the 15th Meeting of the Conference of the Parties to CITES, Mar 2010, Doha (Qatar), the meeting adopted amendments to the CITES Appendices which list the species that are protected under the Convention. We wish to inform you that the following species have been included on CITES Appendix II, which means that any import and export of these plants including their parts and derivatives, would require CITES permits. The listing in CITES will enter into operation from 23 Jun 2010.

Aniba rosaeodora #12

#12 refers to Logs, sawn wood, veneer sheets, plywood and essential oil (excluding finished products packaged and ready for retail trade).

This means finished products that contain *Aniba rosaeodora* derivatives that are packaged and ready for retail trade eg. perfume, are excluded from CITES controls.

Bulnesia sarmientoi #11

#11 refers to Logs, sawn wood, veneer sheets, plywood, powder and extracts.

This means logs, sawn wood, veneer sheets, plywood, powder and extracts (including essential oil) are subject to CITES controls. Finished products that contain the essential oil will not be subject to the provisions of the Convention.

Please declare the existing stocks using the enclosed declaration forms if your company possesses existing stocks of essential oils. The completed form must be returned to AVA by 18 Jun 2010. The declaration of pre-Convention stock is to facilitate the issuance of CITES reexport permit after 23 Jun 2010.
