## SINGAPORE'S RESTRICTION OF HAZARDOUS SUBSTANCES ("RoHS") IN ELECTRICAL AND ELECTRONIC EQUIPMENT ("EEE") UNDER THE ENVIRONMENTAL PROTECTION AND MANAGEMENT ACT

With effect from <u>1 JUNE 2017</u>, the National Environment Agency ("NEA") will be restricting six Hazardous Substances in Electrical and Electronic Equipment ("EEE") under the Environmental Protection and Management Act ("EPMA") as follows:

A Hazardous Substances Licence will be required from Pollution Control Department ("**PCD**") for the import, export and sale of new mobile phones, portable computers, refrigerators, air conditioners, panel TVs and washing machines containing parts and/or components exceeding the stipulated limits above. Application for a Hazardous Substances Licence can be made online at -<u>http://eservices.nea.gov.sg/pcls/</u>.

3 There will be a prohibition on the import for local sale of the 6 new EEE that exceed the above stipulated limits. Companies are required to apply for a Hazardous Substances licence for import of such EEE for re-export. Companies with existing stock of the 6 EEE that are imported before 1 June 2017, need not apply for a Hazardous Substances Licence. Existing stock of the 6 EEE are allowed to be sold until depletion.

4 Importers/traders are to submit to NEA a once-off declaration of conformity per company, to show proof that the 6 HS in the 6 new EEE comply with NEA's requirements. A template of the declaration of conformity can be found at URL link in Para 6.





## Harmonized System ("HS") and Product Codes

5 The list of HS and Product codes are listed in **ANNEX A**. As some of the equipment mentioned in paragraph 2 such as mobile phones, wireless devices installed in portable computers are also controlled by the Infocomm Media Development Authority ("**IMDA**"), a joint TradeNet<sup>®</sup> Permit application will be required for import. With effect from 1 June 2017, traders are required to declare the import and export TradeNet<sup>®</sup> permit applications using the appropriate HS and Product codes. All permit applications will be subject to PCD's processing and approval.
