### **Enforcement operations net three suspects with haul of more than 4,700 cartons of duty-unpaid cigarettes**

Singapore Customs arrested three men, aged between 44 and 54, and seized more than 4,700 cartons of duty-unpaid cigarettes during related operations conducted in the vicinities of Bedok North Street 5 and Woodlands Avenue 6 on 18 August 2021.

#### Case information

On the evening of 18 August 2021, Singapore Customs mounted an operation near Bedok North Street 5. Officers moved in after observing boxes, suspected to contain duty-unpaid cigarettes, being transferred from a Singapore-registered van to a Singapore-registered truck. The truck driver, a 44-year-old Chinese national, was arrested after 1,700 cartons of duty-unpaid cigarettes were found in the two vehicles.

In a related operation on the same evening at Woodlands Avenue 6, officers uncovered 2,996 cartons and 40 packets of duty-unpaid cigarettes in another Singapore-registered van. The driver and the passenger of the van, a 47-year-old Singaporean man and a 54-year-old Malaysian respectively, were arrested.

A subsequent search at the Singaporean man's residence at Yishun Street 22 led to the seizure of an additional 64 cartons and 37 packets of duty-unpaid cigarettes.

The two operations resulted in the seizure of three vehicles and a total of 4,760 cartons and 77 packets of duty-unpaid cigarettes. The duty and Goods and Services Tax (GST) evaded amounted to about \$407,160 and \$32,660 respectively. Cash amounting to

\$12,750, which was suspected to be criminal proceeds from the sale of duty-unpaid cigarettes, was also seized from one of the suspects. Investigations are ongoing.

Buying, selling, conveying, delivering, storing, keeping, having in possession or dealing with duty-unpaid goods are serious offences under the Customs Act and the GST Act. Offenders can be fined up to 40 times the amount of duty and GST evaded and/or jailed for up to six years. Vehicles used in the commission of such offences and proceeds of sales of duty-unpaid cigarettes are also liable to be forfeited.

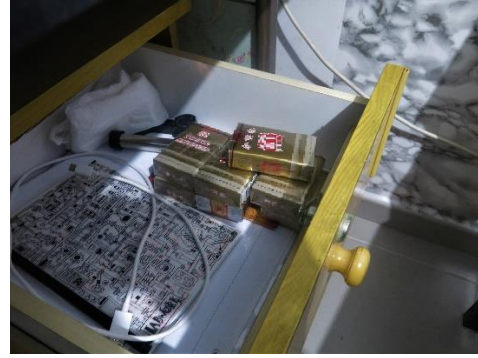
